The first inspection is performed by CV4 and is the initial inspection to confirm your unit is up to code. The second inspection is performed by the Township of Manchester and is for the same purpose.

Both CV4 and the Township have their own checklist for their inspections, which are available to you.

If your buyer requests a third-party inspection, and they opt to have an outside contractor perform the work, then their work is required to be inspected by CV4, hence a possible third inspection.

White-tailed Deer fawns are born April through July, with the majority of fawns born in June. Most first-year does will have one fawn each year, but twins or triplets are typically seen thereafter.

Until they are strong enough to keep up with their mothers, deer fawns are left alone while their mothers go off to feed. Mother deer will stay away from the fawns to avoid leading predators to their young. Does return at dawn and dusk to feed and/or move their young.

Fawns are typically left in an area with tall grass or bushes, but sometimes they are left in more open areas, including backyards. Older deer fawns may wander short distances. Well-meaning humans often assume that because a fawn is alone it must be an orphan, leading to numerous fawn "kidnappings" each year.

A fawn has the BEST chance of survival when cared for by its mother. Typically, the best option is to leave the fawn alone!

If you see an injured or dead deer, fawn or wild animal, please contact the NJ Fish & Wildlife. Additionally, Crestwood Village Four cannot dispose of any dead wild animals. ## GIVE US A BRAKE

Speeding through Village Four has become so problematic that it can no longer be ignored. Some type of intervention is now required and we are taking necessary action to keep everyone here safe.

Irresponsible speeding drivers who ignore the 20-MPH speed limit signs are found on just about every street at any given time and continue to put everyone at risk. Residents find it near impossible to enjoy walking our streets with cars whizzing by with no regard for their safety. Our maintenance staff are often working in streets, whether collecting garbage, removing trees, or picking up curbside debris each month

and have advised the board that there have been plenty of near-misses. Maintenance crews have reported that people actually drive around the safety cones placed around the large bucket truck and drive on curbs and lawns to pass the truck rather than wait for oncoming cars to pass so they can then pass safely on the road.

Asking speed limit violators to change their careless driving habits would be a waste of time so we are thinking of other ways to enforce the speed limit rule. We are currently researching the cost of speed strips to counteract the blatant disregard of our rules and at some time in the immediate future you may see these being installed as a test on one of the main offending streets, Hudson Parkway.

A few immediate steps are closing off sections of streets where work is being done and having cars re-routed with detour signs so they don't get close enough to our crews to cause any harm as well as wearing reflective vests (weather permitting), and hanging CAUTION tape where necessary.

Being extremely concerned for the safety of everyone involved we are taking this matter seriously and will be implementing these policies and procedures this summer.

For those who abide by the 20-MPH speed limit, thank you for having the respect everyone should have for our neighbors and workers.

### WEEKLY TRASH REMINDERS

Now that the Board of Trustees is conducting in-person interviews for potential residents, one of the first questions we ask is what brought them to Village Four and the answer we most often get is that Village Four is the prettiest of all the other villages and looks to be well maintained.

We are very proud when we hear this but it also makes us take a step back to some of the realities that we constantly deal with, one being trash removal. Our maintenance staff are our eyes on the ground and report back to the challenges they face weekly regarding what residents leave out to be hauled away.

We have reminded everyone over and over again that there are limits to what trash will and will not be picked up. As in any residential community, garbage is understood to be items such as food scraps, paper towels, tissues, and other **basic** household items. Not included in weekly trash collection are items such as building materials, mechanical or computer devices, bicycles, furniture, or anything placed in large black plastic contractor bags. Although these items were often collected as a courtesy, this is no longer the case. Anything that is not considered basic household trash in regular trash bags will be left behind for the resident to dispose of.

Recycling items like boxes and hard plastics are not considered basic household trash and should be placed in a recycling receptacle for bi-monthly pick up. If these items are left by the trash receptable on any other day they will not be picked up and the resident will be fined.

As always, if you have specific items you want removed you can call the office and request a price quote for our maintenance staff to collect as a separate removal.

### **RUINING THINGS FOR EVERYONE**

This board worked hard last year to come up with ideas to keep residents active and happy throughout the unprecedented shut down of most activities we all took for granted.

When we decided to offer residents a monthly Curbside Debris Pickup and the opportunity to hold their own garage sales, monthly, and for NO fee to the village, we were thrilled to partner with everyone, as we are residents too.



Until recently, these have been monthly activities that residents seem to enjoy and appreciate, but there are always one or two who push the limits and ignore the rules because they think those rules apply to everyone but them.

Over Memorial Day Weekend, a resident on Monticello Drive deliberately ignored the rules and took advantage of what the Trustees hoped would be a nice gesture by allowing everyone to hold a garage sale on the last Saturday (<u>only</u>) of the month. This resident started setting up on Thursday, then had the sale on Friday, Saturday, Sunday, and part of Monday (Memorial Day). A District Rep and a Trustee separately spoke with this resident to advise that this was not allowed and were told that he/she was going to do whatever he/she wanted and there was nothing anyone could do about it. This resident was called after the weekend and advised that he/she was being fined for the days the sale was not allowed.

This is not the first time a resident violated the rules and hosted his/her own sale with complete disregard for the rest of us.

It's unfortunate that we had to issue a fine for something that was meant to bring our community together at a time when neighbors were more important than ever.

Sadly, if this happens a third time, the board will rescind the monthly garage sale policy and revert back to what other boards have done in the past which was allow 2 sales each year (spring/fall) with a \$5.00 charge for anyone who participates.

In the meantime, the Trustees will be removing any posted signs with the exception of the allowable last Saturday of each month so nobody knows the sale is happening.

Monthly Curbside Debris Pick-Ups have faced the same flagrant disregard towards our rules. Too many piles of sticks and yard debris have been thrown to curbs based on the whim of some residents instead of the monthly Wednesday schedule. These unsightly piles often sit for weeks at a time undoing all the hard work we put into keeping our Village looking nice. Like the garage sales, this monthly service will be rescinded if people continue to toss their twigs and branches to the curb on any day other than the first Wednesday of each month.

## PARKING POLICIES TO BE STRICTLY ENFORCED BEGINNING JULY 16


With more and more people moving into our village, the parking situation has become out of control and is now being addressed with a clear-cut zero-tolerance policy and dedicated staff to enforce that policy. You may have seen 4 cars squeezed into a double driveway where the vehicles are inches away from the front steps to someone's unit, making it impossible to enter the unit. Residents who park like this have no regard for their immediate neighbor, other village residents, the community aesthetics, or unit access for emergency vehicles.

The trustees met with office staff and the head of our District Reps to develop a plan to deal with these chronic parking offenders.


After the initial written warning vehicles will be immediately towed at the owner's expense. Because the soft enforcement has not been successful in eliminating the violations up to this point, the only remaining option is to remove vehicles that are in violation any of the parking rules.

As a reminder, here are the main parking offenses that are the focus of the enforcement policy:

- No parking is permitted on the grass
- No vehicle at any time is to be parked in the driveway with any portion of it extending into the street
- At no time is "overnight" street parking permitted (12:00am-6:00am).
- Commercial vehicles (commercial lettering) shall not be parked "overnight" (12:00am-6:00am) in multiple unit parking areas, any driveways, or in the street.
- Each Certificate Owner in a multi-unit building with no garage (Madison, Essex, & Windsor), is entitled to one (1) designated parking space. Certificate Holders may not use the guest spaces for their second vehicle.
- Guest Parking Spaces are to be used for Guests of that building only.
- At no time are 3 vehicles allowed to be squeezed together side by side to fit into a double driveway. Only I vehicle per side is allowed unless you were permitted to install additional driveway spacing.
- Vehicles left in an <u>apparently</u> inoperable condition will be considered abandoned.



\*Vehicles in violation of the above rules may be considered "abandoned" after one (1) written warning is left on the windshield of the vehicle. After one (1) written warning the vehicle is subject to towing at the owner's expense.
