

**A MESSAGE FROM YOUR BOARD OF TRUSTEES...** Back in 1789, Benjamin Franklin famously made a quote that "nothing is certain but death and taxes" (even though he was referring the newly ratified Constitution, particularly in relation to the US system of taxation). Well, hopefully everyone took care of their taxes in April, now what about death. Death is a subject many shy away from, don't want to discuss or even think about, but, unfortunately, it is an absolute. On that note, I want to inform you, our Certificate Holders, your heirs, family and/or friends, what our By-Laws state regarding "Transfer of Membership" in the event of the "Death of a Member".

Section 8. of our By-Laws entitled Transfer of Membership (a) Death of a Member states that "Upon the death of a member, the legal representative of the decedent shall, within thirty (30) days after the date of death, notify the Closing Supervisor of the Co-Op in writing of the name and address of the person who has succeeded to the decedent's right and interest in and to the Membership Certificate and Proprietary Lease. Withing ninety (90) days of the date of death, the legal representative, or the person who has succeeded to the decedent's interest in the Co-Op shall delivery to the Closing Supervisor the Membership Certificate, Proprietary Lease issued to the decedent, certified copies of decedent's Will, Letters Testamentary or Letters of Administration and death certificate, inheritance tax waivers, and such other documents as the Board of Trustees may require. Thereupon the Board of Trustees shall cause a new Membership Certificate and a new Proprietary Lease to be issued in the name of the person who succeeded to decedent's interest subject however to all terms and conditions of these By-Laws, and provided said person shall qualify for membership." The Board understands the emotional difficulties involved when a loved one passes, so if an extension of time is required, we will work with you. The By-Laws also state that the only time a new Membership Certificate and Proprietary Lease can be issued to someone who does not meet the age requirement is "where the successor is the spouse of such deceased member, said spouse may succeed to the right and interest of the deceased member in the Co-Op, irrespective of the age of the surviving spouse, and without the necessity of approval by the Board of Trustees; however, if the underage surviving spouse remarries, he/she or the new spouse must be over the age of fifty-five (55) years."

In summary, when a Certificate Holder passes away, the Co-Op must be notified within 30 days of the passing that the Certificate Holder passed away and within 90 days, the Co-Op must receive certified copies of the Will, Surrogate's Court Certificate or Letters Testamentary, death certificate, copies of the front and back of the Executor's driver's license, the original Membership Certificate or a notarized letter stating the original Membership Certificate cannot be found (there is a \$100 fee for a lost Membership Certificate), Proprietary Lease, and any applicable tax waivers. Again, while we understand talking to our loved ones about death can be difficult, the more educated you are, the easier it will be for them.

### HOPA - 2024 AGE VERIFICATION SURVEY FORM

Under Title VIII of the Civil Rights Act of 1968 (The Fair Housing Act), as amended by the Fair Housing Amendments Act of 1988, The Housing for Older Persons Act (HOPA), signed in to law in 1995 defines housing for older persons as housing intended and operated for occupancy by at least 80 percent of the community or one person 55 years of age or older per unit. To keep a housing community or facility for older persons the Statutes require that Associations claiming the exemption establish age verification procedures.

It is mandatory that this survey be <u>fully completed</u> and <u>filed with the Co-Op Office</u>, no later than <u>10/15/2024</u>. It only needs to be filled out and sent in once in 2024.

### ALTERNATE DISPUTE RESOLUTION (ADR) IS BACK! <u>ADR PROCEDURES</u>

The ADR is an intermediary between the following:

- $\Rightarrow$  Resident and Board of Trustees
- $\Rightarrow$  Resident and Resident
- $\Rightarrow$  Resident and Club

### **STEPS:**

(1) Resident comes to the front window and requests an ADR form.

(2) Resident completes the ADR form and gives it to the Office Manager, who date stamps and initials the form, and then seals it in a manila envelope. The envelope is NOT to be reviewed or opened by anyone, including the ADR Committee.

(3) The Office Manager has <u>ten (10) days</u> from the date the ADR form is received to contact the ADR Chairperson and notify him/her that there is an ADR matter.

(4) The ADR Chairperson contacts his/her ADR Committee, and they contact the Complainant and Respondent and decide on a time and date that is mutually acceptable for all parties.

(5)On the day of the hearing, the ADR Chairperson and the ADR Committee retrieve the sealed envelope from the Office Manager 30 minutes prior to the ADR hearing.

(6) The Committee conducts the hearing. If the resolution is mutually agreed upon, the matter is given to the Board of Trustees for review.

(7) If the matter is NOT mutually agreed upon, the Complainant and Respondent must find other avenues outside the Village to resolve the complaint.

**NO ANONYMOUS LETTERS** *please...* I understand this issue has been printed in past newsletters; however, I would like to inform new residents, as well as remind existing residents, of the procedures regarding submitting complaints and violations. Additionally, the Office has been receiving an abundance of anonymous complaint and violation letters. While we would like to address them all, we can only take action when you include your name and contact information. It's important for us to know that the complaint is valid by ensuring the identity of the complainant. Your information will NEVER be released to anyone outside the office, and permits us to contact you in the event we require further information.

Without this procedure in place, anyone can make an anonymous complaint against someone they have a gripe against, or a neighbor who they claiming are violating the rules. To be fair, we will not accuse anyone of wrong-doing without discussing it firsts with the person who witnessed the violation. It's also important for residents to get physical proof (photo, video), of any infraction, if possible, as it adds credibility and proof that the infraction is actually occurring. Keep in mind though, we do not want anyone putting themselves in jeopardy by taking pictures of people without their permission. We just want photos of the actual violation. You can also contact your Advisory Board Representative and provide them information on the infraction. They will then bring the information to the office where it will be reviewed. Again, without your information, we will have no way of discussing this matter with you.

Due to the exorbitant number of complaints and violations the office is currently receiving, we have put a new procedure in place to expedite our response. We know this delay while staff is learning how to address them can be frustrating, we do we appreciate your patience.

We're all here to help our members, but we need your cooperation to allow us to do so. It is not fair to members who abide by the Rules & Regulations, when others wantonly violate them. Thank you for your cooperation.
